

Formula Funding Resolution

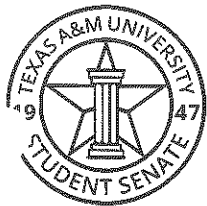
"A resolution opposing all Formula Funding cuts"

Whereas(1): Formula Funding is the template for the distribution of monies per school from the State of Texas general fund for Higher Education Instruction Financial Aid and Research and,

Whereas(2): The Texas Higher Education Coordinating Board is responsible for coordinating the funding of the Texas higher education system:

i. Their recommendation for higher education funding for the 2018-2019 biennium is that Texas legislators "return formula funding rates to the rates appropriated for the 2010-11 biennium by phasing in increases over the next three biennial, and increase the rates by 2.3 percent for inflation." (THECB (2016). Formula funding recommendations for the 2018-19 biennium. Austin, TX.)


Whereas(3): Enrollment at Texas A&M University continually increases with every passing academic year. However, as the Legislative Budget Board notes, that funding for the total Higher Education Fund is marginally higher than that of the 2006-2007
