Distinguished Student Recognition Change Bill

"A bill asking Texas A&M University to change Student Rule 11 and modify the required credit hours students must take to qualify for academic honors."

Whereas(1): According to the Student Rules, Part I: Academic Rules, Rule 11: Distinguished Students reads:

"An undergraduate student who completes a semester schedule of at least 15 hours or a summer session schedule of at least 12 hours with no grade lower than C and with a grade point ratio of not less than 3.5 for the semester or for a summer session shall be designated "distinguished student." A student who, under the same circumstances, achieves a grade point ratio of at least 3.75 also shall be designated as a member of the "dean's honor roll." First semester freshmen must complete a semester schedule of at least 15 hours with no grade lower than a "C," no Q-drops and with a grade point ratio of not less than 3.5 for "distinguished student" designation and a 3.75 for "dean's honor roll."

Whereas(2): 10 of 13 Southeastern Conference schools to require students to take 12 hours to

be recognized as academically distinguished instead of 15; and,

Whereas(3): Other distinguished Texas institutes of Higher Education such as Baylor, Rice, and Texas Christian University also only require 12 hours for their academic

honors, which is the national norm Texas A&M should follow; and,

Whereas(4): Based off the Registrars website for the GPR distribution of Spring 2015 and Fall

2014, lowering to 12 hours would mean ~12% of A&M students would meet the

criteria for the accolades; and,

Whereas(5): The requirement for all other benefits of being a full-time student, which is twelve

hours in a semester at Texas A&M, is simply being in the minimum number of

hours which qualifies you as a full-time student; and,

Whereas(6): A student can be considered full time while taking less than twelve hours if it is

their last semester before completing their degree plan and graduating, which

should not invalidate them from academic honors recognition.

Therefore Let it be

Enacted(1):

That Texas A&M recognizes the accomplishments of all full-time students and the student body, through Student Senate, recommends Student Rules, Part I:

Academic Rules, Distinguished Students to read:

"An undergraduate student who is considered a full-time student with no grade lower than C and with a grade point ratio of not less than 3.5 for the semester or for a summer session shall be designated "distinguished student." A student who, under the same circumstances, achieves a grade point ratio of at least 3.75 also shall be designated as a member of the "dean's honor roll." First semester freshmen must also be considered full-time students with no grade lower than a "C," no Q-drops and with a grade point ratio of not less than 3.5 for "distinguished student" designation and a 3.75 for "dean's honor roll."
