


Rules and Regulations Chair Fernando Sosa,

I, Finance Chair John Cary Cheshire and the attached Student Senators do hereby file articles of impeachment against Student Body President Reid Joseph for the failure to comply with his legal duties as SBP. Despite multiple notifications of neglected duties and persuasive attempts to carry them out, the Student Body President has repeatedly and deliberately broken the Constitution and SGA Code and has willfully neglected his obligations. Additionally, his Executive Cabinet has been fluid for almost the entire duration of this academic year and has been rocked with repeated resignations of members confirmed by the Student Government Association. For those reasons, I feel I am morally bound to exercise impeachment by petition, as I twice swore the following oath:

"I Cary Cheshire do solemnly swear to faithfully execute to the best of my ability the duties of the office of Student Senator & Finance Chair for the Texas A&M University Student Government Association; to uphold the honor of the same; at all times to protect the welfare of the student body; and to promote good relations between the students and those concerned with the University."


It is my belief that the honor of the Student Government Association of Texas A&M has been impugned by the actions of the Student Body President and that he should be required to submit his case before the Student Senate for review.

Because I believe that the Student Body President can no longer honorably or effectively exercise the obligations of his office. I, Chair John Cary Cheshire and the Senators whose signatures are attached do hereby file articles of impeachment against Student Body President Reid Joseph for the failure to comply with his legal duties as Student Body President, his degradation of the honor of the Student Government Association both by inaction and by poor leadership in the Executive Cabinet, and the damage caused as a direct result of his actions.




