- Whereas(1): The Texas A&M University Student Government Association serves as the voice of all students of Texas A&M University; and,
- Whereas(2): The Texas A&M University Student Government Association believes in the importance of shared governance; and,
- Whereas(3): The Texas A&M University Student Government Association recognizes the importance of dining as an organization to the welfare of the students; and,
- Whereas(4): Prior to developing the current structure for the mandatory meal plan Dining Services and Residence Life conducted a single joint focus group consisting of 19 students; and,
- Whereas(5): At that focus group consensus was reached that a requirement of \$1000 or more would be a far too expensive mandatory meal plan option; and,
- Whereas(6): Tax is not currently included in meal plan price quotes, adding an extra 8.25% to the cost of all meal plan purchases, including the planned mandatory meal plan; and,
- Whereas(7): Current rent rates are \$2,627 per semester for the most expensive accommodations and \$1,446 per semester for the least expensive accommodations on campus; and,
- Whereas(8): The planned \$1200 mandatory meal plan would increase rental rates by 50% to 90% for on campus residents; and,
- Whereas(9): A \$800 mandatory meal plan, the planned requirement for upperclassmen living on campus starting in 2015, would only increase rental rates by 33% to 60% for on campus residents
- Whereas(10): University Dining's stated purpose for raising the mandatory meal plan was to increase the profitability of the organization; and,
- Whereas(11): University Dining is currently providing food to student organizations, such as the Texas A&M University Student Senate and Texas A&M Residence Hall Association at no cost; and,
- Whereas(12): In September of 2010 a survey of students showed a 78% of opposition rate to the idea of any mandatory meal plan; and,

Whereas(13): In October of 2010 the Texas A&M Residence Hall Association and the Texas A&M Student Senate passed legislation requesting that the meal plan options be further discussed with the student body before a final decision was made; and,

Whereas(14): No official response to this legislation was ever provided.
