

Speaker of the Senate

- Whereas (1): Due to COVID-19, many Aggies are no longer present in College Station but are currently back home, whether that be in Texas, in the United States or globally; and,
- Whereas (2): During the COVID-19 pandemic, there has been an increase in incidents of blatant racism and aggression towards people of APIDA (Asian Pacific Islander Desi American) descent and Asian Americans; and,
- Whereas (3): A TAMU-affiliated organization publicly tweeted a xenophobic and derogatory tweet regarding the COVID-19 pandemic; and,
- Whereas (4): The Battalion published an article, that spoke of some Aggies' use of derogatory and demeaning remarks towards Asian Americans and those of Asian descent; and,
- Whereas (5): In 2015, the World Health Organization published a "Best Practices for the Naming of New Human Infectious Diseases">2 in which they highlighted that naming diseases based on geographical locations, cultures, populations, or occupations should be avoided. Past diseases such as the Spanish Flu and the Middle Eastern Respiratory Syndrome were cited as naming conventions to avoid; and,
- Whereas (6): Terms such as "Chinese Virus", "Wuhan Flu", and "Kung Flu" or similar variations attach a racial and ethnic stigma to the disease, regardless of the intention, and opens up groups to be unjustly targeted; and,
- Whereas (7): According to Dr. Reber, the Dean of Student Life for Texas A&M University, there have been a total 112 Stop Hate reports regarding the aforementioned tweet in Whereas 2 and four Stop Hate reports regarding "two separate GroupMe's, associated with a class, where a student used terms like 'Chinese virus' and 'Corona Boy'", thus highlighting that Texas A&M Students have been impacted and concerned by said actions; and,

- Whereas (8): The Department of Justice released a statement<sub>3</sub> cautioning against the spread of misinformation that proves harmful towards ethnic minorities and individuals of descent; and,
- Whereas (9): The Anti-Defamation League also highlights over 70 specific cases of coronavirus-related anti-Asian incidents, across the U.S, with several cases in the state of Texas. Based on an FBI intelligence report compiled by the FBI's Houston office, the FBI has warned, of an increase in hate crime incidents against the Asian American population in response to misinformation associating the spread of the virus to these populations.

Resolved (1): The 73rd Session of Student Senate supports all APIDA/Asian American Aggies during this time, no matter where they may currently be, in the United States or globally; and,

Further Resolved (2): The 73rd session of the Student Senate condemns all racist, xenophobic, or derogatory behavior towards all people regardless of their race or ethnicity; and,

Resolved (3): The 73rd session of the Student Senate recognizes that hateful speech and behavior do not represent our Aggie Core Values of Respect, Integrity, and Excellence; and,
